Minutes

Item 1 Welcome and competition policy

JP drew the attention of the meeting to the GS1 competition policy

Item 4 Actions and review of minutes

Item 5 GS1 UK contract with NHS Digital

A new five-year contract has been agreed with GS1 UK Ltd after the previous agreement expired at the end of March. The contract, which enables NHS organisations to continue to use GS1 barcodes for patient wristbands, provides greater clarity around the use of GS1 standards and around financial liabilities. It also includes access to the Global Location Number registry, which allows barcodes denoting locations to be centrally stored to prevent duplication. The contract provides an escalation process via NHS Digital in case of disputes and allows organisations to purchase additional consultancy services. To continue to use these services, NHS organisations need to sign a revised set of membership terms and conditions or to sign up if they have not done so previously. CIOs are asked to ensure a named person takes responsibility for this and is a point of contact for GS1 UK Ltd.

Item 6 HUG objectives

Objectives were discussed for the various topics that have been agreed. These are:

- **Staff ID** – Review original document and amend where appropriate. Subgroup to meet and agree what else is required ahead of Sept HUG meeting. Stuart MacMillan to lead.
Action – CC to coordinate a skype call with SM, and other identified trusts, and circulate existing guidelines.
- **Case study development** – minimum of six case studies to be written by Dec 19. NS to coordinate.
Action – NS/CC to coordinate follow up with identified trusts
- **EPCIS group** – Coordinate a group to be formed to review and validate Healthcare Core business vocabulary. JH to lead.
Action – Set up a subgroup to validate
- **Registries** – Discussion re: the progress being made at Derby with National Joint Registry (NJR) and the MRI process mapping.
Action – CC to set up a call with MHRA, NJR and Derby to progress activities.
- **Recall** – MHRA promoting the use of GTIN/GLN in medical device alerts but needs support of GS1 UK to promote webinar education for suppliers as to the information required.
Action – CC to discuss with Mig Smith/Chris Florey re: opportunity for webinar delivery and amendments to the spreadsheet.
Recallnet – AC discussed the requirement and overwhelming request for a similar portal to automate recalls.
Action – CC/JH to discuss internally in GS1 UK and feedback at Sept HUG

Item 7 Global Model Number

AC shared that European Commission intend to announce the identifier to be used in the next two weeks.

Item 9**Derby implementation example**

Team attended to demonstrate the implementation of e-Observations. They showed how the system requires that the patient wristband is scanned, and staff ID is scanned, before the observations are taken and results transferred into the electronic patient record via Wi-Fi. Time released to care and accuracy were noted as the pilot successes. Plan is to scale up across all wards.
