#### Item 2 **Competition policy**

Glen Hodgson drew the attention of the meeting to the GS1 competition policy.

#### Item 4 MDIS update

#### **Emma Summers/Laura Prenton**

Emma Summers presented an update on the NHS Digital (NHSD) Medical Device Information System (MDIS). Emma is responsible for the NHSD Cumberlege programme supporting recommendations from the report and is the MDIS product owner.

- There are three project areas
  - A pelvic floor information system
  - B medical device information system
  - C medicines information system
- MDIS is a five-year programme for a UK wide system focusing on high-risk devices for NHS and private providers
- Regulations for MDIS will be determined over next year to set out what data will be collected from whom and how it will be used
- Core services under MDIS medical device data collection, medical devices surveillance, product information master (PIM), patient outcomes, recall, and patient and product registries
- Also have a web form or hybrid where info cannot be sent electronically there will be a web form
- Working with
  - MHRA what MDIS can do for them
  - GIRFT NHSE/I and GIRFT clinical support
  - NICE and CQC to understand benefits for them
- Link to direction for pelvic floor information
- Starting with historical data from 2017 and routine collections from organisation
- Modular approach core data module

#### Item 5 MHRA consultation process

#### **Bayode Adisa**

- MHRA are create a future regulation of medical devices in GB world class regulatory safety system that prioritises patient safety
- Informal consultation already taken place to get an idea of what people want to see
- Formal public consultation on future regulation in GB to be shared mid to late August
- Consultation open for ten weeks including what issuing identities should be used, nomenclature to be used e.g., EMDN or GMDN - range of different aspects to be included in the consultation
- Would like all to get involved with one person from each organisation to respond
- Early 2023 MHRA hope to be able to agree a position and finalise secondary legislation
- New medical device regulatory framework in force by July 2023

#### **Future GB medical device regulation**

- Few changes introduced in Jan 2021
- From Jan all classes of devices have had to be registered with MHRA but with grace periods



- Past first main deadline May 2021 legal requirement for all class III, class IIb and active implantable devices to be registered with the MHRA
- Approaching next deadline in September 2021 for class IIb non-implantable medical devices and class IIa medical devices to be registered with MHRA
- MHRA now have one million registration submissions half include higher risk devices
- Ambition to make the information publicly available and the registration data will be one of the main sources to MDIS

Aim of the workstream was to provide clear visual of where GS1 standards fit into CLMA. Group already established. Consideration to whether the GDE toolkit should be updated as part of this workstream. AD mentioned d,m+d HE toolkit due to be launched at the end of the week.

❖ Sustainability Neil Hind

- Agenda picking up pace. Massive increase in comms to CEOs reminding them of the Net Zero green agenda. Now regional MoUs in place. Every trust has to do a green return at the end of every quarter.
- New emerging standard NHS Evergreen supplier sustainability framework for suppliers to state how green and sustainable they are.
- Department for transport are launching electric HGVs nine to go into the NHS.
- Reuse, recycling agenda including pilots with reusable gowns and walking aids.
- LT Most large corporates have own sustainability programmes. ABHI are trying to help. Most helpful if information requested from suppliers was standardised.
- AD Medicines sustainability board led by Clare Foreman, director of medicines policy. Focus on supply chain environment, specifically inhalers in GP contract, inhalation anaesthetics and anaesthetic gases in trust standards contract. Sustainability fellow due to start in October.
   Opportunity to learn how data joins up along these different streams using GS1 standards.

- Most responses received on draft template. With GL to add final points and recirculate.
- JM Emma referenced questionnaire for MDIS, and it would be beneficial to include to the business case.

- JG provided update for NHS Wales.
- Ministerial approval for S4S programme. Confirm that Omnicell are their IMS partner. The
  programme is an all-Wales programme working all health boards, with NWIS, Digital Health and
  Care Wales (DHCW), and system wide adoption of GS1 standards.

### NHS Scotland update

**Gordon Oates** 

- GO provided an update for NHS Scotland
- Deloitte selected to produce a Scan4safety business case including core enablers and primary use cases. Business case will focus on stakeholder engagement and support from NHS Scotland and

Scottish Government Health and Social Care Organisation to establish governance paving the way for future use cases.

- Initial programme business case will facilitate track and tracing of products and equipment, through acute care, UDI and patient and consultant level costing.
- Awarded Genesis the IMS contract starting in September with point of care scanning.
- Since 21 July workshop taken place to get feedback from NHS Scotland on potential standards.
- Up to central initiative to look at single national approach to implementation of GS1 standards.
- NHS Scotland are planning to use 'Track to Transform' in place of Scan4Safety.

- GSRN adoption is 46%
- GTINs is 26% scanning in IMS to patient
- GLNs is 25%

Forecasted percentages for end of year:

- GSRN adoption is 52%
- GTINs is 34% scanning in IMS to patient
- GLNs is 35%

### Item 13 Feed us the Facts campaign

- Sarah Atkinson shared the work done on the Feed us the Facts campaign to improve information provision in alignment with Natasha's Law.
- Food packaging is the 7<sup>th</sup> least trusted source of data for the UK population.
- The aim is for greater transparency across the food supply in order to inform and protect
- GS1 UK will also be looking at instances on hospital cases that have been aligned with allergens to understand the impact.
- Keen to facilitate discussions on technology to support the problem.
