GS1 UK update

George Lawton

GS1 Global

- Native recognition programme is on track, Proof of concept accessing product information UNICEF and TRVST resolver is good to go. Moving to pilot phase with 50 manufacturers.
- Likelihood is a global resolver will be built
- Electronic patient information leaflet – current focus on potential funders with agnostic solutions. Paper here

GS1 UK

- EPR Guidance in final draft of review. Few final updates and to be sent out in approx. Two weeks for final review from HUG members
- New Hospital Programme – supplier engagement and importance of GS1 standards working towards a plan of engagement and inclusion of GLNs to be included in the Hospital Design toolkit

- Future connectivity team [RTLS guidance](#) updated to include information on GS1 standards
- Wound care management pathway with GS1 standards in progress
- [Scan4Safety research article](#) called "Complexities and capabilities of Scan4Safety in NHS hospitals: a qualitative study of a national demonstrator site" now available.

Tracey Francis

- Standards accepted and approved Information Governance Board
- Working with Welsh Govt to have the Welsh Circular published in the next couple of months

NHS Scotland programme update

Lindsay Robertson

- Target to have traceability of 75% of class III and IIb medical devices
- Working to go live in four health boards currently
- Ready to start UAT on Medical Devices Data hub with two health boards: Golden Jubilee and NHS Lothian
- Doing work around data and analytics and how tie into wider health datasets and info that PHE Scotland provides
- National Medical Equipment Management System- harmonising the data across all the boards and delivering a technical solution. Working on a new Target Operating Model on this
- New Comms and Engagement manager working on SharePoint site to give health board colleagues resources to get data in best possible shape
- Funding extended for programme another year
- By end of next financial year should have 12 health boards live with point of care scanning
- Product recall example is good endorsement for the programme

Department of Health and Social Care (DHSC) update

Jasleen Rehal

- Green light to launch the Procurement for Beta for the Product Information Master (PIM)
- Delivery partner estimated to start in May

NHS England update

- None given as Anna took unexpected leave

NHS Supply Chain

Frankie Wallace

- Currently live in nine trusts, eight of those Trusts are point of care scanning
- York and Rotherham went live in February and Bolton live this week (commencing 3 March)
- Stock audits underway
- Some Trusts have recruitment freeze in place, so resource is a challenge for them to support and causing delay
- Also aiming for traceability of 75 per cent class III and IIb medical devices
- Captured £1million across seven Trusts of write-off and wastage

- Siobhain shared an example in Ireland of a trust providing scanners for all staff and on boarding rather than informal borrowing between departments

Action: LR to reach out to SD to discuss this example with the team at the trust in Ireland

National Equipment Tracking Information System (NETIS) update

Curtis Fallows

- Pulling to data, standardise and have real time access
- Built a proof of concept in April 2024
- Found since better ways of doing things
- Agreement and proposal to ingest asset data directly from Trusts directly from asset system
- Plan to obtain info on 80 per cent of assets using APIs without any requirement from Trusts
- Currently writing to CEOs at hospital Trusts to raise awareness and then asking for approval – need this before developing technical side
- By Oct 2025 plan to receive 60 per cent of assets from Trusts with 85 per cent by April 2026 – this will help drive some informed decisions
- Premise is asset data and product data – data standardisation where global standards come in
- Working with MHRA get access to product library
- Believe will have 2.5 million assets in the system for go live

MHRA update

- Premarket SI is closed and all responses being reviewed and awaiting response to be released soon
- After this intend to share with WHO in May/June and parliament in December
- If passed should come into force May 2026 – By 2029 UDIs will be mandatory
- Registration fees update is still with the Minister

Loan kit workstream

- Loan kit working group supported by Jackie Pomroy – current writing a guidance on best practice for managing loan kits. Next step to go to suppliers and solution providers

Pharmacy workstream

- Amna Khan Patel has written a paper on closed loop medicines system. She will be presenting about this at the conference alongside two blueprints on this. Re-establishing pharmacy working group to co-chair the group

Staff ID workstream

- Introduced to DSIT for intro to team working on digital identification. Trust framework exists for this already and GSRN is a potential component of this. Also, gone back to Ian's team to push the GSRN as a verified credential for staff identification as part of the digital staff passport programme.
