GS1 UK update: GL

- New Hospital programme (NHP) workshop held with NHSE NHP team and Mott McDonald to process map traceability of products across supply chain to hospital site
- Amna Khan Patel and JG upcoming meeting to discuss pharmacy round table
- Scan4Safety advisory group collaboration
- Supporting NHS trusts with NHS Supply Chain (NHSSC) IMS deployment roll out

Department of Health and Social Care (DHSC) medtech update: JR

- Over past month evaluation of a number of suppliers bidding for alpha phase of the PIM database process soon to choose supplier
- Reached end of process and informing chosen supplier in next few days and they should be starting at beginning of April
- Sending emails to all stakeholders who want to be involved
- High-level plan of what they are trying to do
- Also sending a survey to engage people from different organisations to help kick start the user research



NHS England update: KF

- Hosted the Scan4Safety advisory group, which brings together GS1 UK, NHSSC, Medicines and Healthcare products Regulatory Agency (MHRA), NHS England (NHSE) Outcomes and Registries Programme and NHSE commercial directorate
- Focused heavily on comms recently. Launched the new Scan4Safety (S4S) website and NHS Futures platform. The NHS Futures platform has more practical material for organisations working on S4S whereas the website is more public facing.
- Advisory group has brought S4S together and have a clear message but need to be getting message out more and talking to people across different forums
- Bringing S4S work to the NHSE quality committee to highlight the work being done so driving priority within NHSE
- ASt is working on piece of work on benefits and measurements of benefits from trusts who have adopted S4S
- Also looking at how S4S can improve patient safety for closed-loop medicines and blood transfusion

MHRA medical devices update: PS

- Continue to work on regs/PIM with DHSC and International Recognition Policy still stands
- In January, the MHRA published the regulatory roadmap which can be found here: Regulatory Roadmap points the way ahead for new measures to support safe access to medical technology including AI and diagnostics GOV.UK (www.gov.uk)
- The implementation page was updated at the same time: <u>Implementation of the Future Regulations</u> GOV.UK (www.gov.uk). All the info we can share right now is on this page.

NHS Supply Chain: FW

- Two teams up and running in the In Hospital services business unit Centre of Excellence (CofE) team and deployment teams
- CofE role is benefits realisation keen to capture baseline, explain and validate the benefits creating a benefits toolkit and forecasting tool
- Cameron Kantar has led work with Nils in NHSE, updated savings framework and methodology aiming to make it as transparent as possible and aligning with NHSE's forecasting
- Encouraging consistent approach around inventory management, making sure consistent processes with AsIs/ToBe approaches
- Work done with Barts to look at how NHSSC can support on supply chain issues and management of logistics
- Doing work and engagement on a data standards policy which is near to being published with GS1 being the preferred coding standard
- Structure for IMS framework with NHS SBS to go live shortly
- Part of the S4S advisory group ensuring consistency in activity
- More engagement now with the Federated Data Platform (FDP) and supporting with the supply chain use case for the programme
- Deployment status four trusts West Suffolk, Sandwell and West Birmingham, Rotherham and Newcastle, all with operational partnership agreements signed off

Action: IT highlighted the potential for the enterprise architect team to map out the capability into the NHSE capability map



NHS Wales programme update: ASm and TF

ASm

- Programme kicking on despite some delays. Information governance (IG) took a lot longer. Welsh Ambulance Service also gone live. Cancer centre is final area.
- Results starting to come out of the system so engaging other areas. Momentum is improving.
- Hit all targets bar one volume and value transacted through the system has exceeded. Savings –
 delivered £1.2 million so not on target but IG was the blocker to this.

TF

- Produced two draft standards for GTIN and GLN. Reviewed AIDC standard. With Tracey for a second review. Drafted Welsh health circular to review with Welsh government.
- Planning patient wristband workshop as wristbands not currently GS1 compliant

NHS Scotland programme update: SW

- Two pilot sites for point of care scanning:
 - 1. NHS Lothian focus on benefits realisation. Had six-month review workshop about what can start to evidence and looking to roll out at other areas at NHS Lothian.
 - 2. Golden Jubilee Live across cardiac surgery, ophthalmology and orthopaedics
- Next is Western Isles and have two health boards lined up for next year already
- Funding confirmed for next year. Still working on the medical device data hub and integration with third party systems including Genesis.
- Kicking off discovery work on medical equipment
- Developed a framework on the data and analytics piece and developing the target operating model
- Website has been revamped

Action: IT highlighted the point that we need to cross-share case studies. NHS Scot comms team and GS1 UK marketing are already aligned. GL to ensure case studies are shared across borders.
