Item 1: Presentation

- UDI triggers and GS1 healthcare GTIN allocation rules – Ian Whitham, GS1 healthcare leadership team (HCLT) member, Cook UK and Dennis Black, UDI Program Director, BD (HCLT member)
- Ian, Dennis, and Chris presented the proposal to review the rules to align them with regulatory requirements and avoid unintended consequences for manufacturers, healthcare providers and registries
- The UDI triggers working group will present to the HCLT before it moves forward to the Board Committee for Standards (BCS). If approved launch a new MSWG (Mission Specific Work Group) and proceed based on the GSMP process and project plan

Item 2: Minutes and actions review

- Frankie provided an update on the IMS programme. The team is recruiting more people to support the deployment team and is trying to maintain consistency across the NHS. They are also recruiting a clinical engagement manager to support the deployment team.
