Item 1: Presentation

- Debbie Stevenson presented on Manchester University NHS FT's Scan4Safety programme, highlighting its benefits, challenges, and the importance of GS1 standards in healthcare

Item 2: Minutes and actions review

Item 3: GS1 UK update

- GL provided updates on GS1 UK's activities, including joining the Professional Record Standards Body (PRSB) and efforts towards native scanning of the GS1 DataMatrix

Item 4: NHS SC IMS programme

- FW discussed NHS Supply Chain's efforts in addressing data and barcode challenges, emphasising the need for GTINs at all packaging levels and the importance of barcode quality. Working with CF to adapt the current GS1 UK webforms to allow trusts to report data issues.
