Item 1: Presentation

- Simon discussed Elcom's involvement in inventory management systems (IMS) and their use of GS1 standards. He highlighted the importance of accurate data capture, and the challenges faced in the healthcare sector.

Action CF: To reach out to the Medicines and Healthcare products Regulatory Agency (MHRA) for a potential session on new regulations and UDI requirements in the UK

- GL updates on the National Outcomes Registries Programme and upcoming webinars. She also mentioned the GS1 UK conference scheduled for April next year.

Item 5: Customer facing colleagues training session

- CF mentioned delivering training sessions for Cook Medical's customer support and delivery teams. Positive feedback was received and the offer was extended to other organisations.

- CF and participants discussed the issue of multiple barcodes on products and the importance of having a single barcode for simplicity and accuracy
